



Call for Submissions to HeART of Healthcare Gallery

Patients for Patient Safety Canada is seeking art submissions for an online exhibition honouring World Patient Safety Day, September 17, 2021, on this year's theme of "Safe maternal and newborn care".

On World Patient Safety Day we will launch an additional virtual art exhibition, **HeART of Healthcare: Safe and Respectful Maternal and Newborn Care**, which will include works in various media including: paintings, fibre art, poetry, stories, sculpture, dance, and music.

The aim of World Patient Safety Day 2021 is to raise global awareness on the issues of maternal and newborn safety, particularly during childbirth. Childbirth should be safe and respectful for all people in Canada. People should have their choice of birthing options and the medical support necessary to ensure they and their babies are safe before, during, and after birth. All people in Canada should feel supported, respected and safe, and everyone should have the same access to safe and quality care, including those living in rural, remote and isolated communities.

For more information and details on the submission process, please download the submission form. Submissions are encouraged from patients, healthcare workers, leaders, and supporters from every walk of life.

The submission **deadline is September 3, 2021 11:59pm (MST)**.

Artists in any form, at all levels, who create work inspired by these themes are asked to submit the following:

- For **2D Visual Media**: high quality digital images of each proposed work. (300dpi, JPEG format, around 2MB in size)
- For **3D Sculptures**: high quality images of at least two angles of proposed work (ex. Front and rear), taken on a white or neutral background. (300dpi, JPEG format, around 2MB in size)
- For **Written Media**: Word format, poems and stories that can fit on one typed page only
- For **Music**: Direct link to download audio file (no longer than 4 minutes)
- For **Performance**: Direct Link to view video file (no longer than 4 minutes)

All Artists are also asked to submit:

- Brief Biography- approx. 100 words.
 - Include full name, mailing address, and email in this document.
- Artist Statement relating works to the theme of the exhibition- approx. 100 words.
- Information about each piece (as appropriate for media): title, dimensions, year completed, media, duration. Please label files with the title of the work.
- Completed permission form to have the art featured in the HeART of HealthCARE gallery (see form below)
